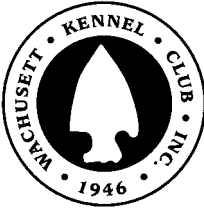

# Again This Year! Pee Wee Class on Saturday



- For kids from 5 to 9 years of age (with a parent or guardian)
- Dog must be at least four (4) months of age to enter
- All dogs must have proper leash and collar
- \$10.00 per child entry fee

Pee Wee Class is a pre-junior showmanship class for children who are at least age 5 and under age 9 years on the date of the show. This is not a competition, but rather a fun and educational learning experience. Each child is accompanied into the ring by a responsible adult who stays with the child at all times; only one Pee Wee Handler and one adult will be in the ring at any one time. The adult is to maintain control of the dog outside the ring as well as ensure control inside the ring. A primary goal is safety and a positive experience for the children, so at the judge's discretion, the adult may be required to attach a second leash to the dog in the ring.

The dog handled by the Pee Wee Handler must be at least four months of age, must be an AKC fully recognized breed or Miscellaneous breed (including dogs with a PAL/ILP listing), and must be registered with the AKC. Bitches in season are not allowed to participate (eligible dogs may be substituted). Dogs must have a proper leash and collar. Wachusett Kennel Club, Inc. will have a show lead and collar available Saturday at ring side, if needed.

Before a Pee Wee participant will be allowed to enter the ring, his or her parent or legal guardian must sign and return a "Release of Liability" form. **Contact Anne Testoni (Information below) to get a copy of the release.**

# AKC Sanctioned 4 & Under 6 Months Puppy Competition Saturday & Sunday

Entry Fee: \$16.00 per puppy

One combined class will be offered for breeds and varieties of dogs that are (4) four months & under (6) six months and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. **There will be a selection of Best 4 & Under 6 Months Puppy in each Breed/Variety**, each Best 4 & Under 6 Months Puppy in Breed/Variety winner will then compete in their respective group for First through Fourth Placements. The Miscellaneous Class Competition will be judged same as above followed by a Miscellaneous 4 & Under 6 Months Puppy Group Competition. The Foundation Stock Service Class Competition will be judged same as above followed by a FSS 4 & Under 6 Months Puppy Group Competition. All First Place Group Winners will be eligible to compete in Best 4 & Under 6 Months Puppy in Show.

An AKC registration number or AKC litter number will be required for entries of an AKC recognized breed or Miscellaneous breed. FSS number or FSS registered litter number will be required for FSS entries.

A foreign born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.*

AKC Rules in *Dealing with Misconduct* will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Show Competition.

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotti Romagnoli, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirnecchi dell'Etna, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
